

## SMALL BUSINESS UNDER PRESSURE 🖐



In 2021, small businesses in Canada employed 8.2 million people, or 67.7% of the total private labour force. By comparison, medium-sized businesses employed 2.5 million people (20.4%), and large businesses employed 1.4 million people (11.8%) [Source: Government of Canada]. Yet , rather than encouraging small business, this government is instead enlarging the public service, which has grown by 30.7% since they took office in 2015 (not including the explosive growth in outside contractors). That is the opposite of how to promote prosperity and create well paying middle class jobs across the country.

### Tax on Beer, Wine and Spirits Still Going Up



In March, the government announced the excise tax on beer, wine and spirits would increase by 2% instead of the 4.75% which their yearly automatic increase required. They called this "tax relief".

Increasing taxes by 2% instead of 4.75% is not "support" or "relief". It's a


tax increase. And it's the 8th annual one in a row without a vote by elected MPs.

My Private Member's Bill C-266 would support brewers, vintners, distillers, restaurants, retailers and millions of cash strapped consumers, while returning the power to set taxes where it belongs - with MPs accountable to voters, by scrapping the automatic annual increase and making MPs vote on each and every tax hike again 🌞

#### **Carbon Tax Hardest on Small Business**

Another hit to small businesses came with the 23% increase to the carbon tax on April. 1st.



# **DEFENCE DEPARTMENT IN DISARRAY**

As a member of the Standing Committee on National Defence, I have numerous opportunities to question the Minister, DND officials and experts about the wide range of challenges facing our troops.

Here are some of the issues I have raised:

- Minister Bill Blair and the Department of National Defence (DND) have an appalling record on Access to Information (ATIP) requests. This affects morale among Canadian Armed Forces (CAF) members. For example, those who are medically discharged, or have sexual assault complaints, can't get the benefits they are entitled to because they can't get the required paperwork;
- This government continues to break its 2015 election promise to be "the most open and transparent government in Canadian history." 40% of ATIP requests are not answered within 30 days as required by law. DND tabled a report that said there are just three outstanding requests more than five years old, but Conservative MP James Bezan revealed that his office alone has four that are between five and seven years old;



 A cyberattack in September shut down the CAF re-location system for weeks. Our troops and their families constantly move from base to base and rely on time sensitive re-location services. MPs heard from CAF members who couldn't access their keys, couldn't access their sale proceeds, and couldn't report to their new assignments on time. Beyond those logistical obstacles, thousands are left to wonder if their personal information is now being peddled on the dark web;



- Lack of access to housing is driving people out of the CAF. The Liberals tried to blame the Treasury Board, but personnel don't care which Liberal minister is to blame for raising their rent. Minister Blair still denies that there are homeless CAF members in Halifax. The DND and CAF Ombudsman, Gregory Lick, disagrees - the evidence is overwhelming;
- The same company that was paid millions for the ill-fated ArriveCAN app – GC Strategies

   also got contracts from DND (some sole sourced) with no transparency about work done. The President of the Union of National Defence Employees claims there is no oversight on contracts, and no way to know what is causing the ballooning costs. ATIP requests go unanswered or are redacted.
